A few weeks ago, I met Aimee Castillo, a young teacher from Pearland. She told me a terrible story about how her brother was followed to his home in the Heights (Houston) and murdered. His murderer had been released on low bond in Houston by a *Democrat judge* for a previous murder. After being arrested for murdering her brother, he was released on bond AGAIN and he murdered a *third person* in Galveston County. This murderer was released YET AGAIN and then **finally arrested** and held without bond in Galveston County. **This is insane!**

The lawlessness in Houston spills over into Brazoria County. Your vote in the November 2022 General Election is an important part of keeping crime out of Brazoria County and supporting our police and judges. We have a great slate of Republican candidates from the top to the bottom of the ballot. Unfortunately, I commonly hear people say they will skip over unfamiliar candidate names when voting—and these are often our judicial races. ***We cannot afford to skip any Republican on the ballot!*** Republican judges will follow the rule of law and the Texas and U.S. Constitutions. It is ***crucial*** for us to have a ***high Republican voter turnout*** in this election and to ***elect every Republican*** on the ballot if we don't want to become like Houston and Harris county! This guide will help you find the nearest polling location, know the polling hours, and become familiar with our Republican candidates. It can be carried into the voting booth.

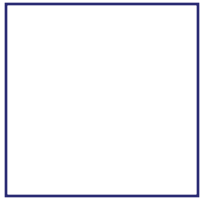

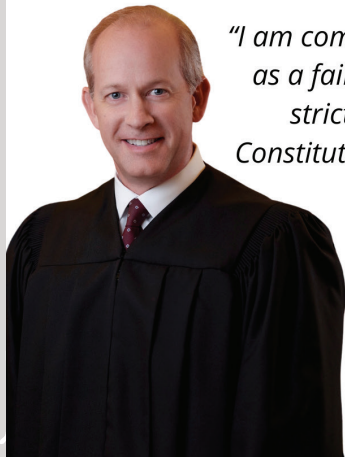
